Mediation and Arbitration Experience

Anne Sone is a lawyer who conducts arbitrations and mediations at the Financial Services Commission of Ontario (FSCO). She has conducted over 2,000 mediations at FSCO since 1997. In 2007, she received a Stella Award from the Ontario Ministry of Revenue. Previously, she conducted arbitrations and mediations for the Licensing Appeal Tribunal of Ontario.
